Changes to Examination Sessions in 2012

From January 2012 teachers whose own studios (Approved Examination Centres) meet the minimum size requirements have the option of holding Intermediate Foundation and Intermediate examinations in their own studios alongside their Graded examinations.

The sessions will be named as follows:

- *Approved Examination Centre (AEC) Sessions:* Previously referred to as Graded Examination sessions, these are examinations that take place in a teacher's own studio (AEC). All Graded levels of Examinations as well as Intermediate Foundation and Intermediate Examinations can take place in an AEC session.
- *RAD Approved Venue (RAV) Sessions:* Previously referred to as Vocational Graded Examination sessions, these are examinations that take place at an RAD Approved Venue. All Vocational Graded levels can be included in these sessions.

36 dancers from South Africa, the USA, Canada, Wales, Scotland, Israel, Malaysia, China, Japan, Australia, New Zealand, Hong Kong, Cyprus and Spain entered this year's Genée International Ballet Competition. The students, all of whom were aged 15 to 19 years and had passed RAD Solo Seal or Advanced 2 with Distinction, participated in 5 days of intensive coaching, then competed in 2 days of semi-finals during which the 12 finalists were selected by judges David Nixon OBE, Artistic Director of Northern Ballet in the UK; Iain MacDonald, Artistic Director of the South African Ballet Theatre; and Professor Elizabeth Triegaardt, Executive Director of Cape Town City Ballet. The final was a stunning event, resulting in the awarding of the medals as noted above. No gold medal was awarded this year. The Audience Choice Award went to Jessica Brown (Australia).

The Genée Dance Challenge was open to South African students up to the age of 17 years. Heats were held all over South Africa and the winners chosen in each of 6 cities represented their region and their ballet schools at the National competition. A total of 36 students performed at Artscape theatre. The candidates were judged on the performance of a ballet solo choreographed by their RAD teacher.

Judges were RAD Artistic Director Lynn Wallis and choreographer Christopher Hampson who selected a winner at each level (four winners in total). Each winner received a trophy, Genée memorabilia and two complimentary tickets to the Genée Final.

“ Attending the Genée International Ballet Competition in Cape Town this year was a rewarding and really fun experience. Cape Town is a beautiful city that was a perfect match for the relaxed atmosphere of the competition. I really enjoyed meeting the other 35 candidates from 14 other countries. Everyone got along really well and we were all friends very early on in the week. I loved the way the feeling of support from each other was stronger than the tension and competitiveness found at most other competitions I've been to before. It really is the “friendly competition”.

It required us to focus on musicality and to interpret the intricate dynamics of the music in a way that made the dance atmospheric and emotional. It was a challenge to learn and polish the dance in five days but one that I enjoyed a lot. Performing this dance along with our pre-rehearsed variations at Artscape at the end of the week was thrilling and topped off the whole experience.

I can't say thank you enough to everyone who organised and ran the event, and Shelley Morgan and Paula Hunt for taking me. I made so many friends and learnt things about dance all around the world that I know will be a huge influence upon my future. I encourage NZ dancers to take the opportunity to attend the Genée in Wellington next year - you'll have the time of your life just like I did! ”

Cheridah was the past president of HB Ballet and Dance and will be remembered by many as the driving force behind the Summer Schools that used to be held annually in Napier in January.

HBBBD Tribute to Cheridah Sewell who passed away at Cranford Hospice 30 August 2011

At the Hawke's Bay Ballet and Dance Inc 41st AGM held on 19 June 2011 Cheridah Sewell retired from the position as president and from the committee. The success and longevity of HBBBD for 41 years was due to Cheridah's lifetime commitment, dedication and work. Cheridah carried on her mother's (founding President Dulcie Malcolm) work to initially support the NZ Ballet Company and then to support and encourage dance and dancers locally in Hawke's Bay. She became a Life member in 2005, and was also honoured to receive a Paul Harris Fellowship from the Rotary Foundation for contribution to the arts community. In November 2009 a Souvenir Booklet covering the history and many achievements of the society was compiled in honour and recognition of Cheridah's work. The booklet notes the 25 years of Summer Schools involving not only ballet, but also modern, jazz, tap, character, contemporary, music, theatre & drama, choreography, Indian, Spanish and Highland dancing; the successes of Scholarships winners; and the association with NZ School of Dance which has graciously allowed students as Guest dancers at the Annual Dance Festivals since 1993. Two of many scholarships and grants HBBBD give to encourage and support dancers locally and nationally are the Poul Gnatt Scholarship which supports a male dancer at the NZSD, and the Dulcie Malcolm Scholarship which supports a female dancer at the NZSD. Most people knew Cheridah as a quiet and unassuming lady with wonderful organisational skills. The Club owes its success to her with many years of support from her family, as her involvement has been a lifetime commitment.

Former winners of the Poul Gnatt and Dulcie Malcolm Scholarships to the NZSD include Craig Bary, Tasi Tuala, Farley Johannson, William Pratt, Daniel Cooper, Kase Craig, Dane Holland, Debbie Fulford, Belinda Harvey, Katrina Dixon, Sarah Knox, Hollie King and Alicia Mitchell.

Benesh Movement Notation

Benesh Movement Notation (BMN) is a universal language for recording movement. The RAD offers a wide range of courses in BMN, from introductory courses lasting two days to a professional diploma. Anyone interested in learning this invaluable method of recording dance or who would like to increase their knowledge will find a course to suit them.

'The professional notator's course was one of the best career moves I made – it has been invaluable for my work as a teacher, répétiteur and choreographer. Just knowing the basics can really help. It is so simple and logical.'

Being able to read the Benesh can be hugely helpful if you need to learn the set work or check movement or rhythmic details.

Benesh Distance Learning Course One

Want to be able to use Benesh notation as a resource in your study and teaching? Enrol on this course. You can start at any time of year – approximately 100 hours over 12 months delivered by distance learning with individual tutorial support provided by phone, fax, email and post.

The course includes study of the basic principles of BMN as applied to the solo dancer (including movements of the limbs and body, direction faced, turns, floor patterns and the expression of rhythm) and practice in reading and recording ballet exercises and enchaînements.

Examinations Information

Overview

The Royal Academy of Dance (RAD) offers an internationally recognised portfolio of examinations and assessments which is designed to motivate and encourage students of all ages and levels of ability, through a systematic measurement of progress and attainment. Examinations are organised and administered by the RAD Examinations Board.

Students may start with the Pre-School Dance Curriculum, move up through Pre-Primary and Primary levels and then into eight Graded levels or six Vocational Graded levels. Students may move from the Graded to the Vocational Graded pathway at an appropriate time, or they may study at both Graded and Vocational Graded levels simultaneously. Types of assessment include Examination, Class Award, Presentation Class and Demonstration Class.

RAD examinations provide students with:

- an achievable goal to work towards;
- recognition from the world's largest ballet examination board;
- qualifications that are fully accredited by the UK regulatory authorities;
- the impetus to achieve their personal best.

The Graded Examinations in Dance syllabus:

- includes our Pre-School Dance Curriculum for candidates from the age of 2½ years;
- includes our innovative new Pre-Primary in Dance and Primary in Dance syllabi for candidates from the age of 5 years;
- incorporates Ballet, Free Movement and Character.

The Vocational Graded Examinations in Dance syllabus:

- builds on the elements covered in the Graded syllabus;
 - is suitable for candidates from the age of 11 years;
 - is intended for students who wish to pursue a career in dance;
 - includes the prestigious Solo Seal Award, the highest Vocational Graded examination offered by the RAD, which focuses on solo performance.

Information on other examination matters such as worldwide fees, entry procedures, results and certificates, and uniform requirements are available in the new publication *Focus on Exams* and in the Examination Specifications. Specification documentation for Graded examinations and Vocational Graded examinations and an overarching document called Examinations Information and Rules & Regulations are now available. Check them out on www.rad.org.uk/examinations. Combined, this documentation replaces the previous Handbook for Teachers publications.

Further Examinations Information

Target Date for Examination Results

Examination certificates and result forms should reach the teacher within 4 weeks of the end of the examiner's tour.

Reduction in Vocational Examination Fees for Members

For those sitting examinations at Advanced Foundation level and higher there is a reduction in exam fees which more than offsets the cost of the membership fee. The Member Exam Fee is available only to candidates who are already Members before the exam closing date.

Special Graded Examinations

The closing date for a session requested outside the published dates is 2 months before the start of the session. The fees are \$350 plus \$50 per day. Any request for a special examination session should be sent to the NZ office with a \$75 deposit which forms part of the fee.

Less than 3 hours' Graded Examining Time

Teachers who have less than 3 hours examination work may choose to hold their examinations in their own studios by paying an additional charge on the total fee income from their examination and class award or presentation class entries to bring it up to the minimum fee of \$1548. This surcharge will not apply if teachers combine with other teachers to ensure a total of more than 3 hours.

Replacement Certificates and Replacement Medals

A charge of \$38 will be made to replace any certificates which are incorrect due to mistakes on the entry form. The same fee will be charged to replace lost certificates. Errors made by the Academy will be corrected free of charge, but in all instances the original certificate must be returned to the NZ office before a replacement certificate can be issued. A charge of \$18 will be made to replace any medals.

Results Enquiry Service

There are two levels of check for the Results Enquiry Service.

Level 1: Results Enquiry clerical check. This provides an additional data entry and monitoring check to ensure that all procedures have been carried out appropriately and marks have been accurately processed and reported. The fee is \$25 per candidate.

Level 2: Result Enquiry Report. This service includes the clerical check and also a detailed Report which provides the reasoning behind the result given. The fee is \$80 per report.

Refund Policy

50% of any examination or presentation class fee will be refunded if a candidate is unable to take the examination due to illness or if the teacher has to cancel the examination session due to illness. No refunds will normally be made for withdrawal for any other reason. In the case of sickness a medical certificate must be enclosed. Both should be given to the Area Organiser or sent to the RAD office within a week of the conclusion of the examination tour.

Age Requirements

From January 2013 examination candidates worldwide must have reached the minimum age by 1 January of the year of the examination (not by 31 December as at present).
